In our effort to grow and diversify our impact and influence in the West Palm Beach community, the men of Delta Delta Lambda Chapter, Alpha Phi Alpha Fraternity, Inc., founded, in January 1997, the "Alpha Phi Alpha Educational Scholarship Foundation, Inc.". The organization was established as a registered non-profit organization under I.R.S. Code, Section 501c3.

The Chapter and Foundation, since its inception, has operated collaboratively, as an outstanding vehicle for service and advocacy. Together we have created or brought to the area, several outstanding educational programs such as "An Evening with Black Artists", "Men of Tomorrow" mentoring program, "Project Alpha" youth symposium and several "Town Hall Meetings "addressing current issues that impact the African American community.

The name of the Foundation was officially changed in 2014, to Alpha Educational Foundation – DDL, Inc.

- College Scholarships Award between ten and fifteen thousand dollars annually to local high school graduates.
- Project Alpha –For over 20 years Alpha Phi Alpha and the March of Dimes working together to help our young men and women make the good decisions about the complex issues pertaining to their sexuality and teen pregnancy.
- Senior Boys Breakfast A forum to recognize and to inform African American males graduating high school with a 3.0 or higher G.P.A., about opportunities afforded to them going forward.
- Town Hall Meetings Public forums to address the issues impacting our community (Crime, Affordable Housing, Economic Development, etc.)
- Voter Registration and Voter Participation Drives
- Dr. Martin Luther King, Jr. Memorial in Washington, D.C. Raising funds to support the building and maintenance of the memorial in honor of Dr. King.

Mission Statement:

The Judge Edward Rodgers Center for Community Development, located in the City of Riviera Beach, exists to help build a vibrant, 21st-century community rooted in equality of opportunity for all residents of Riviera Beach and neighboring cities.

We pursue this mission by offering impaction programs and services to at-risk, high-risk, and undeserved youth and families in and around the city. As an innovative social collaboration led by the Alpha Educational Foundation – DDL, Inc., an arm of the Delta Delta Lambda Chapter of Alpha Phi Alpha Fraternity, Inc., the Rodgers Center is designed to serve as a trans-formative social enterprise. The Center will deliver seven key community empowerment offerings, equipping Riviera Beach residents with the resources, skills, training, and potential employment opportunities they need to build stronger futures—and, in turn, a stronger local community.

The Foundation, together with its partners, will operate out of its primary facility at 251 W. 11th Street, Riviera Beach, Florida (the former site of the Riviera Beach Maritime Academy). From this hub, we will offer cutting-edge community benefits to deserving residents, including but not limited to:

- Educational Enhancement Programs
- Healthy Food and General Nutrition Resources
- Music Appreciation and Cultural Enrichment Initiatives
- New and Small Business Incubation Services
- Mental Health Screenings and Access to Counseling
- Youth Mentoring and Recreational Sports Opportunities
- Workforce Development Training and Skills Based Learning

Just as importantly, by partnering with local, state, and national organizations—as well as with business and industry leaders—the Rodgers Center aims to achieve the following objectives:

- Strengthening and expansion of the youth based local mentoring program, Men of Tomorrow, which is in its 38th year, using evidenced based practices and local industry exposure opportunities.
- Creation and implementation of various workforce development initiatives, to
 include apprenticeship opportunities in both the marine and hospitality industries,
 that will provide at-risk, high-risk, and undeserved youths and juveniles and exoffenders with the training and job opportunities they need to become productive
 and contributing members of society.
- Implementation of a proprietary Musical Engineering Certification Program, in partnership with organizations that provide career-based skills and employment opportunities in the digital music and audio-visual industries.
- Development of a New Business Start-Up Incubator, providing entrepreneurs with the infrastructural resources they need to grow and further develop their businesses.
- Creation of a Mental Health Service Delivery Mechanism to serve as a liaison to veterans suffering from post-traumatic stress disorder (PTSD), as well as grief counseling services and other under-addressed mental healthneeds in the community.
